The Board met with Town & Country (WCA) Route Manager Mark Zink at Wednesday's Board Meeting held on August 3rd regarding the ongoing service issues since WCA bought out Town & Country in October 2015.

Mark advised the board that they have lost drivers because they now pay by the hour, before they paid by the day. They no longer hire just anyone; they must have a clean driving record and not be a felon. 75% of the employees are new and they are working closely with the new employees that they have hired to get them trained. He asked us to give them 60 days to show improvement for service in our subdivision. He has given us his email address for any service issues. If you have any service issue please contact us. 




Beautification Program ... We have a rebate program to help promote landscaping. It is called the Windermere's Beautification Program. This year we are doing our program differently. Homeowners that want to be considered will submit a request to be considered by June 1st 2017. You will receive \$50.00 rebate for your tree or perennial you planted in your yard visible from the street. If your tree or perennial (annuals do not qualify) cost less than \$50.00 you will receive that amount. Maximum rebate is \$50.00.

The HOA will rent a dumpster and you can get rid of all your unwanted household items in you home, basement and garage.
